

Terms and Conditions of Use

Please carefully read the following Terms and Conditions of Use ("Terms of Use") before using this website ("Site"). By using this Site, you agree to follow and be bound by these Terms of Use, which govern your use of the Site. Nothing contained in these Terms of Use is intended to modify or amend any other written agreement, if any, that may currently be in effect between you and GotExams with regard to matters other than your use of the Site. We may periodically modify these Terms of Use, and any such modifications will be effective immediately upon posting. We suggest that you periodically check these Terms of Use for modifications. If you do not agree to these Terms of Use, do not use this Site.

1. Accounts

You need an account for most activities on our platform. Keep your password somewhere safe, because you're responsible for all activity associated with your account. If you suspect someone else is using your account, let us know by contacting our support team.

When setting up and maintaining your account, you must provide and continue to provide accurate and complete information, including a valid email address. You have complete responsibility for your account and everything that happens on your account, including for any harm or damage (to us or anyone else) caused by someone using your account without your permission. This means you need to be careful with your password. You may not transfer your account to someone else or use someone else's account without their permission. If you contact us to request access to an account, we will not grant you such access unless you can provide us the login credential information for that account.

If you share your account login credential with someone else, you are responsible for what happens with your account and GotExams will not intervene in disputes between students or teachers who have shared account login credentials. You must notify us immediately upon learning that someone else may be using your account without your permission (or if you suspect any other breach of security) by contacting our Support Team. We may request some information from you to confirm that you are indeed the owner of your account.

2. Exam Purchase and Lifetime Access

When you purchase an exam, you get a license from us to view it via the GotExams Services and no other use. Don't try to transfer or resell exams in any way. We grant you a lifetime access license, except when we must disable the exam because of legal or policy reasons.

Under our Teacher Agreement, when teachers publish an exam on GotExams, they grant GotExams a license to offer a license to the exam to students. This means that we have the right to sublicense the exam to the students who attempt the exam. As a student, when you attempt an exam, whether it's free or paid, you are getting from GotExams a license to view the exam via the GotExams platform and Services, and GotExams is the licensor of record. Exams are licensed, and not sold, to you. This license does not give you any right to resell the exam in any manner (including by sharing account information with a purchaser or illegally downloading the exam and sharing it on torrent sites).

In legal, more complete terms, GotExams grants you (as a student) a limited, non-exclusive, non-transferable license to access and view the exams and associated content for which you have paid all required fees, solely for your personal, non-commercial, educational purposes through the Services, in accordance with these Terms and any conditions or restrictions associated with a particular exams or feature of our Services. All other uses are expressly prohibited. You may not reproduce, redistribute, transmit, assign, sell, broadcast, rent, share, lend, modify, adapt, edit, create derivative works of, sublicense, or otherwise transfer or use any exam unless we give you explicit permission to do so in a written agreement signed by a GotExams authorized representative. This also applies to content you can access via any of our APIs.

Teachers may not grant licenses to their exams to student directly and any such direct license shall be null and void and a violation of these Terms.

3. Payments & Return Policy

When you make a purchase, you agree not to use an invalid or unauthorized payment method. If your payment method fails and you still get access to the exam, you agree to pay us the corresponding fees within thirty (30) days of notification from us. We reserve the right to disable access to any exam for which we have not received adequate payments.

Once you pay for an exam, there won't be any option for any reversal of payments. In case you are unable to access an exam due to technical issues, we will assist you through our support team and find you a solution.

4. Exams Content

GotExams is a marketplace for exams and GotExams is not responsible for the quality of the contents, the contents (Plagiarism) and exams. Ratings are provided against exams and users are advised to use that to judge and then take exams. Questions and exams can be reported to keep the quality in check.

5. Using GotExams at Your Own Risk

Our platform model means we do not review or edit the exams for legal issues, and we are not in a position to determine the legality of exam content. We do not exercise any editorial control over the exams that are available on the platform and, as such, do not guarantee in any manner the reliability, validity, accuracy or truthfulness of the exams. If you attempt an exam, you rely on any information provided by the teacher at your own risk.

By using the Services, you may be exposed to content that you consider offensive, indecent, or objectionable. GotExams has no responsibility to keep such content from you and no liability for your access to any exam, to the extent permissible under applicable law. You assume full responsibility for the choices you make before, during and after you attempt an exam.
